## Prices and Terms of sale

## ♦ Prices

To reserve a kitten, a reservation contract is drawn up between the seller (us) and the buyer (you) and we ask for a deposit corresponding to 25% of the price including VAT of the kitten. From then on, you will regularly receive news of your future savannah kitten to be able to follow his evolution. Please note: a deposit commits you and is not refundable in the event of withdrawal on your part, except in the event of an agreement with the seller. However, if the kitten has a deficiency that compromises his sale, we will offer the refund of the entire deposit or the transfer to another kitten. The remaining 75% to be paid will be paid at the time of the acquisition of the kitten.

The price of a hybrid savannah kitten depends on his generation, his quality and his destination (company or breeding). They may vary and are therefore given for information only.

## ♦ Legal obligations

Our kittens are all declared to LOOF and/or TICA. All our breeders are free from genetic mutations linked to the onset of diseases specific to the Savannah breed: PKDef (pyruvate kinase deficiency) and APR (progressive retinal atrophy). The mother and father of the kittens are tested FIV and FeLV negative before each mating.

We sterilize the kittens before leaving the cattery, except in the case of an agreement for breeding rights (contact us to find out more).

The kitten will be delivered up to date with its mandatory vaccinations (typhus, coryza,  $\pm$  rabies), chipped (microship) and dewormed. The following documents will also be given to the buyer when acquiring the animal:

The sales contract

The certificate of transfer of animals of non-domestic species (cerfa n°14367\*01)

The invoice

The European passport and/or health record

The declaration of marking of an animal of a non-domestic species (cerfa n°15969\*01)

The I-CAD provisional identification certificate

The filiation register (RF) at LOOF and the declaration of mating and birth (DSN) and/or the TICA registration

The certificate of genetic analysis proving parentage

The research certificate for the following genetic diseases: PKDef and APR

The veterinary certificate of good health dating from less than 2 weeks and the results of the analyzes (negative FIV/FeLV, negative coproculture)

The Savannah health, feeding and education advice sheet

Legal warranties and remedies

The kitten will leave the breeding with a complete outfit: transport basket, harness, toys, blankets, treats, food, etc.

## ♦ Modalities fo taking possession of the kitten

The kitten will be free to leave the breeding from his 4 months and he will be delivered by hand either on the site of the breeding, or at the residence of the purchaser, the expenses caused by the transport being the responsibility of the buyer. We absolutely want to have contact with the new owner of our kitten.

In the event of sale outside French territory, we undertake to provide all the documents (CITES permit) and test results (rabies) necessary for the export of the animal. In this case, we advise you to contact us quickly so that we can find out from the authorities in your country about all the documents that will be required of you when importing your hybrid savannah.
